Release Highlights From 4.7

- Case Discontinuation: NBIS will automatically trigger the closing of a case when an investigation is discontinued in PIPS, enabling the initiating Org to reinitiate, as necessary.
- Inheritance abilities: User assignment templates and form routing workflows can now be assigned or selected by sub-orgs.
- Awaiting Subject Revision Cases: Cases returned to the subject for correction with an "Awaiting Subject Revision" status will populate in Task Management.
- eApp Email Update: Allows users to have the ability to send a modified copy of one or both eApp subject Initiation emails to a secondary email address.

NBIS Tip of the Month!

Global Expiration Timers

As part of a hotfix included in release 4.6.5, the issues identified with global expiration timer countdowns has been corrected. The hotfix ensures cases which pass the designated global timers will expire as intended.

Cases that show a negative number of days until expiration are being cleaned up over the next few days.

NOTE: Users should ensure cases released to DCSA for a background investigation have not passed 120 days from the date of certification or the request will be returned unacceptable.
