- > One important enhancement of the 4.7.2 release is the Obligating Document Number (ODN), which is a billing code in the Financial Details section of the order form and a required field deployed in 4.7.2.
 - Cleared Industry Addition of the code requires NO ACTION. The NBIS team worked with AVS (formally VRO) to add the correct ODN into the Order Form Templates, which are available to all Industry users in the NISP Contractor hierarchy in NBIS.
 - Federal Agency The system is not verifying the accuracy of ODNs at this time; however, as a best practice, we recommend updating your order form templates in preparation for future capabilities.
- Our first Quarterly Update Meeting was held October 1, 2024. This focused on our partnership with DCSA's Personnel Security team and our continued efforts to establish better communication with our stakeholders going forward.
