WHERE TO GO FOR NBIS TRAINING

All National Background Investigation Services (NBIS) training resources are accessible via Security Training, Education, and Professional Portal (STEPP). Visit STEPP for NBIS training materials including job aids, e-learnings, video shorts, learner paths, and registration for live webinars. Access to STEPP requires an account, and the site is now accessible via a more secure Smart Card Login (scroll to bottom of page to locate). If you have not done so, please set up your account by following the prompts on the STEPP homepage by selecting Create New Account with DOD CAC or Non-DOD CAC.

Once logged into STEPP, navigate to the NBIS Training Homepage by selecting "Training" in the top left, and select "NBIS" from the drop-down list.

Tip: For ease of access to links within this training update, it's recommended to log into STEPP prior to selecting any of the links.

FINDING JOB AIDS & KNOWLEDGE ARTICLES IN STEPP WITH EASE

- 1. Log into STEPP and navigate to the NBIS Training homepage.
- 2. From the NBIS Training homepage, select **NBIS Job Aids**.
- 3. Select Expand All on the right side of the screen (this will open all the menus and make all job aids and knowledge articles visible).
- 4. Type CTRL+F on the keyboard (this will activate a search block in the top right corner of the page).
- 5. Enter the topic to learn more about (for example initiate, attachments, user roles, etc.).
- 6. All job aids and knowledge articles relevant to the searched topic will be highlighted on the page. Navigate down the page to see items with that topic name.

FIND A LEARNER PATH

On STEPP, under the End-User Training, you will find various topic areas such as NBIS Overview & General Tasks, Subject Management, Adjudication Management, etc.

Under those main topic areas, you will find a link to <u>Learner Paths</u>. These learner paths provide a recommended series of courses to help the end-user navigate the training materials and ultimately be better prepared to navigate NBIS.

There are currently learner paths covering the following topics: Foundational, Case Initiation (one for Industry; another for Agency), Subject Management, and Adjudication.

The NBIS Training Program is continually updating and adding new end-user training materials to STEPP, to include enhancements to the overall user experience on the site. Mark STEPP as a <u>favorite</u> on your browser and visit often.

TRAINING PRODUCT DEVELOPMENT

NBIS Training regularly assesses the training needs in each NBIS release through its alignment with the iterative NBIS development. The needs are prioritized based on mission and user impacts, and level of effort to update or create new materials. For example, the removal of the pencil icon – this change impacted the bulk of the training catalog. NBIS Training is currently in the process of updating all training materials to reflect the change to the blue hyperlink. Please refer to the Modify a Subject Job Aid for reference.

DIFFERENCE BETWEEN JOB AIDS AND KNOWLEDGE ARTICLES

On STEPP, you will find Job Aids and Knowledge Articles. What's the difference?

Job Aids are meant to show step-by-step actions – essentially a guide demonstrating how to perform the task(s). Knowledge Articles are more informational and provide more in-depth discussion to strengthen a user's understanding of a particular topic.

EARN CERTIFICATES FOR NBIS TRAINING

Following completion of a learner path or webinar, users can obtain a certificate to use to obtain Professional Development Units (PDUs) needed to maintain professional certifications obtained through CDSE.
