THE EVOLUTION OF CDSE OFFERINGS


Virtual offerings are one of the many reasons CDSE is a pioneer in security education. Our learning management system, the Security Training, Education, and Professionalization Portal (STEPP), allows students to learn without the restrictions of previous models. However, this was not always the case. Most of CDSE's training in the early days was instructor-led (ILT) and classes were supplemented with correspondence courses using CDs, PDF documents, and online tests.

"The ability to train 3,000 individual students was a good year back then," said Erika Ragonese when interviewed for our 10 Year Anniversary Celebration in 2020.

In 2023, there were over 4.8 million course completions.

CDSE's current combination of ILTs, virtual instructor-led training (VILT), and eLearning has improved our ability to provide enhanced learning opportunities to more students. Through the effective use of technology, CDSE provides affordable courses that reach more students both domestic and international. Virtual access to content also represents significant cost savings to taxpayers as the high costs of training are largely associated with travel and lodging.

With the evolution of technology and ubiquitous on-demand access, CDSE's




workforce delivers an expansive library of training offerings, covering 11 content areas. These content areas include counterintelligence, cybersecurity, general security, industrial security, information security, insider threat, operations security, personnel security, physical security, and special access programs. These content areas contain multiple courses for security professionals to acquire knowledge that is useful in their profession. In addition to the previously mentioned ILTs, VILTs, and eLearning, CDSE also uses shorts, job aids, webinars, and toolkits to educate students. These delivery methods allow learning to take place anytime, anywhere.

CDSE also hosts multiple webinars and conferences annually using a virtual platform. Not only does this save cost with less travel and logistics planning, but more participants can be reached with the use of our virtual event platform. Participants can attend from their own offices or homes and still ask questions in real-time.

CDSE's evolution from its founding in 2010 to current day is filled with "firsts" that would eventually become the standard for our security education. Security shorts were launched in 2011, webinars were started in 2012, and VILTs and toolkits were introduced in 2013. The first virtual DOD security conference was held in 2014, and the first hybrid DOD security conference took place the following year in 2015. In 2016, we hosted the first virtual speaker series and in 2017 the first hybrid (ILT/VILT) course was taught. In 2018, we held the first virtual DOD security conference for industry. In 2019, we pioneered the first Insider Threat Awareness Month. In 2021, we also expanded our mission to include background investigation training for internal investigators. In 2022, CDSE partnered with Credly to provide digital badges for SPēD Certifications and ACE credit-recommended courses. In 2023, the CDSE Education program introduced the Post-Baccalaureate Certificate program.

CDSE will continue to innovate using academic best practices and technology advances to develop new products and delivery methods in order to meet the training and professionalization needs of our security community. Incorporating academic best practices and effectively using technology will become a force multiplier for delivering quality security training, certification, and education offerings to an increasing number of students that is available anytime and anywhere.

INSIDER THREAT DETECTION ANALYSIS COURSE (ITDAC)

Counter-Insider Threat Analysts, registration is ongoing for several upcoming iterations of the ITDAC. 
This virtual instructor-led course teaches entry level participants how to apply critical thinking skills and applicable structured analytic techniques to potential insider threat indicators. Learners will also obtain and use holistic data in conjunction with the application of critical pathway theory.


