SPED CERTIFICATION

SPed CERTIFICATION PROGRAM OVERVIEW

The Security Professional Education Development (SPēD) Certification Program is part of the DOD's initiative to professionalize the security workforce. Established in DOD Instruction 3305.13 and DOD Manual 3305.13, this initiative ensures there exists a common set of competencies among security practitioners that promotes interoperability, facilitates professional development and training, and develops a workforce of certified security professionals.

In general, candidates are eligible to pursue SPeD certification if they are DOD personnel performing security enterprise functions or federal employees of a participating agency within the security workforce. Contractors assigned to and performing security functions on behalf of the DOD are eligible if requirements are outlined in either their Performance Work Statement (PWS), Statement of Work (SOW), or authorized in writing by the Contracting Officer's Representative (COR). Eligible candidates must meet outlined prerequisites based on the specific certification or credential they are pursuing. For example, an eligible candidate must first obtain the Security **Fundamentals Professional Certification** (SFPC) before they are eligible to pursue the Security Program Integration Professional Certification (SPIPC), Security Asset Protection Professional Certification (SAPPC), or Special Program Security

Certification (SPSC). Adjudicators at agencies accepted into the program must complete prerequisite training before they are eligible to take the Adjudicator Professional Certification (APC) and must obtain the APC prior to attempting the Due Process Adjudicator Professional Credential (DPAPC). There is no specific prerequisite for the Physical Security Certification (PSC), and only Antiterrorism Officers (ATOs) are eligible to pursue the Antiterrorism Credential (ATC).

As of April, the SPED Certification Program transitioned its candidate management system (CMS) to Defense Acquisition University (DAU). Current certificants and candidates alike must establish a new DAU account to gain access to program offerings by completing the SAAR form available here.

Following their DAU account approval, new candidates must request to **take an assessment**, by selecting their owning component/agency emblem from the appropriate certification or credential drop-down. This will prompt the candidate to complete the Certification and Credential Enrollment Form that will be routed to their Component Service Representative (CSR) for approval.

As a note, it may take between six to eight weeks for current certificants to see their certifications and credentials reflected in their account once their DAU account has been approved. Due to this system transition, the SPED Program Management Office (PMO) no longer has administrative oversight of account creation, courses, or system access as it did with previous candidate management systems. For questions related to DAU accounts, account navigation or access, eLearning activities, or course offerings, please contact the Help Desk.

The SFPC, SAPPC, SPIPC, and PSC are nationally accredited with the National Commission of Certifying Agencies and are identified as 'Enterprise Certifications.' Achieving a SPeD certification publicly confirms certificants meet comprehensive professional standards and are prepared for success in the security profession.

The SPēD Certification Program currently has three 'Enterprise Credentials'. The Industrial Security Oversight Credential (ISOC) is ideal for DOD, federal members, and Industry under the National Industrial Security Program (NISP). The ATC provides a recognized and reliable indication of a security practitioner's understanding and ability to specify purpose, function, and role of an antiterrorism program. The SPSC is ideal for personnel who will be or are already performing Security Officer functions for and/or on behalf of the Department of Defense Special Access Programs. The SPēD Certification Program also has specialty certifications and credentials which include the Adjudicator Professional Certification (APC) and the Due Process Adjudicator Professional credential (DPAPC). The APC certifies that adjudicators are qualified to perform all essential adjudicative functions related to determining the eligibility of a Government employee, military service member, or contractor employee under the

National Industrial Security Program (NISP) for access to classified information or assignment to sensitive duties. The DPAPC provides the recognition and official record of an individual's demonstrated understanding and application of occupational and technical knowledge, skills, and expertise necessary to proficiently perform essential due process adjudicator tasks (e.g., writing Statement of Reasons (SORs), evaluating responses to SORs, recommending eligibility determinations or other functions following evaluation of responses to SORs).



CERTIFICATION AND CREDENTIAL VALUE

MAINTAINING CERTIFICATION AND CREDENTIALS

To maintain active and up-to-date SPED Certifications, you must earn 100 Professional Development Units (PDUs), 50 of which must be security related, within your two-year maintenance cycle. To maintain an active and up-to-date SPED stand-alone Enterprise Credentials (such as ATC), you must earn 75 Professional Development Units (PDUs), 50 of which must be security related, within your two-year maintenance cycle. You will need to log in to your DAU account to record your PDUs and submit your Certification Renewal Package. If you haven't established your DAU account already, create it as soon as possible, as it can take between six to eight weeks for your account to update and reflect your certifications and credentials.
