SUMMARY

The DCSA Student Experience (DSE) is a paid internship program designed to attract diverse and talented students. Students have an opportunity to gain marketable developmental experience in counterintelligence and insider threat, industrial security, personnel security, security training, and DCSA core mission and support areas.

HIGHLIGHTS

Students work for a required minimum of 10 weeks from June through August as full-time, temporary federal employees. Students that successfully complete the summer program may be eligible to continue the internship program during the semester and non-competitively return for the Summer 2027 Cohort. Students must provide proof of all eligibility items.

ELIGIBILITY

To be eligible, applicants must:

- Be a U.S. citizen.
- Enrolled full-time in an undergraduate or graduate degree program from an accredited college/university with the intention of remaining a full-time student through October of 2027. (Law Students may apply in any year during their JD program.)
- Maintain a minimum cumulative 3.0/4.0 GPA from the time of application, the semester prior to cohort participation, and throughout their employment with the program.
- Obtain and maintain a Secret or Top-Secret security clearance.
- Pass pre-employment and random drug testing.
- Reside in the local commuting area of the selected duty location during summer cohort.
- Meet other qualifications as stated in the announcement.

The DSE Summer '26 Cohort runs from June through August with start dates of 1 or 15 June. The end of cohort is officially 22 August. Students are required to complete a minimum of 10 weeks in the cohort.
