### Subject: Aligned Investigations Reimbursable Billing Rates for FY 2011

The attached billing rates for reimbursable investigative services for background investigations and discontinued billing rates from the Office of Personnel Management's Federal Investigative Services (OPM-FIS) are effective beginning October 1, 2010. The adjusted rates reflect enhancements to investigative coverage for most existing products and increases in operating costs. Enhancements to OPM investigative products are part of the larger security and suitability process reform effort. The leaders of the Office of Management and Budget, Office of Personnel Management, Office of the Director for National Intelligence, and Department of Defense developed a strategic plan to incrementally implement the capabilities needed to achieve security and suitability process reform. Among the deliverables is the requirement to "Align OPM investigative levels (existing products) with Reform concepts"<sup>1</sup> by October 2010.

The FY 2011 investigative products have been simplified by eliminating some of our previous investigative products, including the Limited Background Investigation (LBI), the Public Trust Special Background Investigation (PTSBI), and the Periodic Reinvestigation and Residence Coverage (PRIR). This provides standardization with one level of investigative coverage for each level of risk or sensitivity identified. Requests for the LBI, PTSBI and PRIR submitted on or after October 1, 2010, will be converted to the current product approved for the risk level identified: Moderate Risk Background Investigation (MBI), Background Investigation (BI) and Periodic Reinvestigation (PRI), respectively.

The FY 2011 products have been enhanced to incorporate the expandable focused investigation (EFI) concepts and enhanced subject interviews (ESI) for issue resolution of investigations for moderate risk, high risk and critical sensitive positions. When triggered by events defined in the OPM Investigators' Handbook, the ESI will also be included in the Access National Agency Check and Inquiries (ANACI) and National Agency Check with Law and Credit (NACLC) for non-critical sensitive positions. ESI expansion of the ANACI and NACLC will result in an additional charge. It is estimated that approximately 24% of all ANACI and NACLC investigations will trigger expansion.

Timeliness evaluations demonstrate that the timeliness for standard coverage of the ANACI and NACLC case types has been compressed to be within one day of priority service. Therefore, the benefit of two levels of service for these case types no longer exists and all requests for ANACI and NACLC investigations will be considered expedited service.

For MBI standard service requests, the local law enforcement coverage is first attempted by written inquiry with record searches conducted at nonresponsive or admitted arrest locations. If you want **all** local law coverage scheduled as expedited record searches conducted by field staff, without attempting coverage by inquiry, you may request Priority Service code "A". *Note* - Service Code A relates to the manner in which the local law coverage is obtained, not the estimated case completion time. Overall timeliness for these investigations is heavily dependent on the responsiveness of national, state, and local record providers.

If a scheduled investigation is discontinued and subsequently the same level of investigation is reopened by the same agency within four (4) months from the discontinuation date, the rate charged for the reopened investigation will be adjusted by the amount previously charged. To request a reopen of a previously discontinued case, send the discontinued notice or attach a cover letter from your agency asking for a reopen, along with the case papers, and mail the package to OPM-FIS. Similarly, if a pending investigation needs to have a case type/service change, contact OPM-FIS. Simply submitting the case papers to initiate a reopen or to change case type/service may result in two cases running at the same time and your agency may be billed for both products.
