FY 2019 Initial Estimated Pricing and Customer Agency Budget Guidance

Section 2: Customer Agency Budget Guidance

The guidance in this section is intended to provide customer agencies with tools needed to develop their FY 2019 background investigations budgets. The following sections outline recommendations for estimating an agency's FY 2019 initial costs for NBIB-produced background investigations, to include accounting for additional fees and adjustments.

Estimating Initial Costs for NBIB Background Investigation Products and Services

Case prices shown in Section 1 are applied to an agency's monthly invoices upon receipt of the complete investigation request. Therefore, although the actual final charge may vary based on the actual work conducted, NBIB recommends multiplying your anticipated requests for each case type by the "FY 2019 Initial Estimated Price" shown in Section 1. In addition to the case types shown in Section 1, two additional case types should be considered when estimating costs:

- 1) Reimbursable Suitability/Security Investigation (RSI) – Case Type 43
 - a. NBIB prices and applies RSI requests to monthly invoices according to the specific RSI codes requested by the customer.
 - i. Upon the scheduling of an RSI request, the customer will receive an invoice for the processing fee; itemized fees for requested work completed will be invoiced when the items are completed and the RSI is closed.
 - b. NBIB recommends using an average of \$1,100 per RSI request in FY 2019.
- 2) Special Agreement Check (SAC) – Case Type 92
 - a. SAC requests are priced and applied to monthly invoices according to the specific SAC codes requested by the customer.
 - b. Over 95% of SAC requests are electronic fingerprint submissions.
 - c. If a fingerprint SAC is submitted in advance of the higher level investigation on the same subject, a credit may be applied to the higher level case in the amount of the initial fingerprint SAC. To receive this credit, the requester must:
 - i. Submit the fingerprint SAC at least 1 day, but no greater than 120 days, in advance of the higher level investigation, and
 - ii. Include FIPC Code "I" (letter i) on the higher level investigation.
 - d. Since many SAC requests will ultimately be credited for on a higher level investigation, agencies should only budget for SAC requests that will not link to a higher level investigation (i.e. "Standalone" SAC).
 - e. NBIB recommends using an average of \$25 per "Standalone" SAC request in FY 2019.
 - f. NBIB recommends separately breaking out the \$45 per Continuous Evaluation SAC (CE SAC) request in FY 2019 (see FIN 17-03 for additional details on this new investigative product).

Accounting for Additional Fees and Adjustments

While most additional fees and adjustments are nominal and would have little impact on your overall budget estimate, two major expanded coverage fees should be considered:

- 1) International Coverage
 - a. Applied to each case when casework is conducted outside of the United States and its territories
 - i. May be applied to all case types, excluding SAC requests
 - b. Applied no more than one time per case
 - c. Estimate the percentage of all cases that will receive casework conducted outside of the United States and its territories and apply the estimated fee shown in Section 1
- 2) Triggered Enhanced Subject Interview (TESI) for T2, T2R, T3 and T3R
 - a. Applied to each case when a TESI is completed on a T2, T2R, T3 or T3R investigation
 - b. Applied no more than one time per case
 - c. Estimate the percentage of T2, T2R, T3 and T3R cases that will receive a completed TESI and apply the estimated fee shown in Section 1
 - i. NBIB recommends using a percentage ranging from 25% to 35% of all T2, T2R, T3 and T3R cases an agency expects to submit
